DOH ISSUES IRR ON GRAPHIC HEALTH WARNINGS LAW

The Department of Health (DOH) issued last February 09, 2016 the Implementing Rules and Regulations (IRR) of Republic Act No. 10643 entitled “AN ACT TO EFFECTIVELY INSTILL HEALTH CONSCIOUSNESS THROUGH GRAPHIC HEALTH WARNINGS ON TOBACCO PRODUCTS.”

The IRR applies to all tobacco products that are locally manufactured and introduced in the Philippine market, whether for sale, promotion, public testing and research and other analogous purpose. It also applies to tobacco products imported into the Philippine customs territory including those sold in duty-free shops or by Duty-Free Philippines Corporation.

All cigarette packages and other tobacco product packages, including package inserts and onserts, and any outside packaging and labeling, shall bear Graphic Health Warnings on 50% of the lower portion of the principal display areas or surfaces in accordance with the templates issued by the DOH (Rule III).

Non-compliance with the IRR shall be penalized with Php 500,000 for the first offense, Php 1,000,000 for the second offense and Php 2,000,000 for the third offense or imprisonment of not more than five (5) years or both (Rule VII, Section 2). Administrative fines may also be imposed by the Department of Trade and Industry (DTI) which shall be used for health promotion campaigns on tobacco control.
