After confirming your slot and after paying the reservation fee, please submit to the OCS the following: (a) Official Transcript of Records (OTR) with remarks of "Copy for University of the Philippines; (b) Certificate of Graduation; (c) photocopy of your Philippine Statistics Authority (formerly National Statistics Office)-issued Birth Certificate (original to be presented); (d) photocopy of your Philippine Statistics Authority (formerly National Statistics Office)-issued Marriage Certificate (for married women); and (e) three pieces passport-size colored photographs.
