## 1.0 RATIONALE

- 1.1 Proclamation No. 922 dated March 8, 2020 declares a public health emergency throughout the Philippines due to corona virus disease 2019 (COVID-19).
- 1.2 Memorandum from the Executive Secretary dated March 16, 2020 imposes the implementation of an Enhanced Community Quarantine and the Stringent Social Distancing Measures over the entire Luzon, including the National Capital Region (NCR), effective 00:00 (12 a.m.) of 17 March 2020 and expiring on 00:00 (12 am.) of 13 April pursuant to Proclamation Nos. 929 and 922 (s. 2020) and R.A. No. 11332¹.
- 1.3 Subject memorandum also directs agencies, offices and instrumentalities of the government to adopt a work-from-home arrangement.

## 2.0 SUBMISSION PROCEDURES AND REVISED TIMELINES

To assure the agencies on the available facility for submission of their Budget Preparation (BP) Forms as prescribed in the FY 2021 National Budget Call per National Budget Memorandum (NBM) No. 133 dated November 29, 2019, the Online Submission of Budget Proposals System (OSBPS) shall be accessible/ operational during the community quarantine period.
