Subject : **STREAMLINING THE PROCESS OF ISSUANCE OF AUTHORITY TO PURCHASE MOTOR VEHICLES TO LOCAL GOVERNMENT UNITS CHARGEABLE AGAINST THE LOCAL GOVERNMENT SUPPORT FUND-OTHER FINANCIAL ASSISTANCE (LGSF-FA) TO LOCAL GOVERNMENT UNITS, THEREBY AMENDING LOCAL BUDGET CIRCULAR NO. 119, AS AMENDED, AND LOCAL BUDGET CIRCULAR NO. 122**

1.0 BACKGROUND

The purchase of motor vehicles (MVs) chargeable against the Local Government Support Fund-Other Financial Assistance (LGSF-FA) to Local Government Units (LGUs) is subject to the following existing issuances and guidelines that prescribe the Authority to Purchase Motor Vehicle (APMV) as one of the documentary requirements, to wit:

- a) Local Budget Circular (LBC) No. 119,¹ as amended by LBC No. 199-A,² for the purchase of ambulances, mini-dump trucks, or multi-cabs and/or multi-purpose vehicles, chargeable against the FY 2019 LGSF-FA to LGUs;
- b) LBC No. 122,³ for the purchase of ambulances, trucks, mini-dump trucks, or multi-cabs chargeable against the FY 2020 LGSF-FA to LGUs;
- c) Item 11.1 of National Budget Circular (NBC) No. 446,⁴ as amended by NBC No. 466-A;⁵ and
- d) Item 4.0 of DBM-Department of Finance Joint Circular No. 2016-1.⁶

Subject to the LGU's compliance with LBC No. 119, as amended, or LBC No. 122, as the case may be, the LGSF-FA to LGUs is released by the DBM through the issuance of Special Allotment Release Order and Advice of Notice of Cash Allocation Issued to the Bureau of the Treasury, and the Notice of Cash Allocation (NCA) to the Authorized Government Servicing Bank.

Meanwhile, the issuance of the APMV is subject to the LGU's compliance with NBC No. 446, as amended.

2.0 PURPOSE

This Circular is being issued to streamline the process of issuance of APMV to LGUs, chargeable against the FYs 2019 and 2020 LGSF-FA to LGUs, thereby amending LBC No. 119, as amended, and LBC No. 122.

3.0 GUIDELINES

- 3.1 The documentary requirements for the purchase of ambulances or mini-dump trucks, chargeable against the FY 2019 LGSF-FA to LGUs, specified in Annex B of LBC No. 119, as amended, and purchase of ambulances, trucks, mini-dump trucks or multi-cabs chargeable against the FY 2020 LGSF-FA to LGUs, specified in Annex B of LBC No. 122, are hereby amended as follows:

3.2 Notwithstanding the provisions of NBC No. 446, as amended, the DBM-Central Office, through the Office of the Secretary-Technical Review Unit, shall issue a Confirmation Letter to the LGUs, informing them of the issuance of the NCA for the purchase of MVs, chargeable against the LGSF-FA to LGUs. To support the speedy and timely vehicle procurement for government operations, the Confirmation Letter issued by the DBM to the LGUs shall serve as the LGU's APMV. The purchase of MVs shall be subject to the LGU's compliance with LBC No. 119, as amended, or LBC No. 122, as the case may be, and this LBC.

3.3 Funds released to the LGUs for the purchase of MVs, chargeable against the LGSF-FA to LGUs, shall be used strictly for the purchase of MVs with the same specifications, costs, deployment, and purpose specified in the Confirmation Letter issued by the DBM to the LGU.

Any change in the specifications of the MVs as indicated in the Confirmation Letter shall require approval of the DBM.

3.4 The APMV in the form of Confirmation Letter issued by the DBM is limited to those MVs enumerated under Section 5(a)(1) of Administrative Order (AO) No. 14,⁷ and specified in the pertinent guidelines on the release and utilization of the FYs 2019 and 2020 LGSF-FA to LGUs.

However, the issuance of APMVs for the purchase of MVs under the FYs 2019 and 2020 project menu that falls within the authority of the Department of the Interior and Local Government (DILG), shall be retained with the DILG, consistent with AO No. 14.

- 3.5 LGU requests for fund releases for the purchase of multi-cabs and/or multi-purpose vehicles chargeable against the FY 2019 LGSF-FA shall still be subject to compliance with DBM-DILG Joint Memorandum Circular No. 2019-2.⁸

4.0 ITEMS FOR RESOLUTION

Interpretation of the provisions of this Circular, including relevant items not covered herein, shall be referred to the DBM for resolution.

5.0 SEPARABILITY

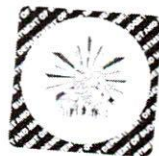
If any provision of this Circular is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

6.0 REPEALING CLAUSE

- 6.1 All provisions of existing guidelines that are not consistent with this Circular are hereby revised, modified, and/or repealed accordingly.
- 6.2 All other provisions of LBC No. 119, as amended, and LBC No. 122 shall remain in full force and effect.

7.0 EFFECTIVITY

This Circular shall take effect after fifteen (15) days from its publication in the Official Gazette or in a newspaper of general circulation.
