**En Banc Resolution No. 04-20**  
(Series of 2020)

**WHEREAS**, under Article 220 (formerly 215 of the Labor Code of the Philippines, as amended by Republic Act No. 9347, the Act Rationalizing the Composition and Functions of the National Labor Relations Commission (NLRC) which took effect on 26 August 2006), the President of the Republic of the Philippines may extend the services of the Commissioners up to the maximum age of seventy (70) years upon recommendation of the Commission En Banc;

**WHEREAS**, Commissioner **ERLINDA T. AGUS** of the NLRC Second Division, is set to retire on 25 October 2020 upon reaching the age of sixty-five (65) years;

**WHEREAS**, on 10 June 2020, Commissioner **ERLINDA T. AGUS** formally manifested in writing her desire to have an extension of her term of office for two (2) years beyond the date of her retirement, as above-stated;

**WHEREAS**, the Commission *en banc* in a session took note of the past and continuing record of exemplary performance, laudable achievements and valuable contribution of Commissioner **ERLINDA T. AGUS** to the NLRC;

**WHEREAS**, an endorsement for the extension of the services of Commissioner **ERLINDA T. AGUS** was submitted to the Commission to enable her to continue her dedicated service to the NLRC;

**WHEREAS**, upon proper deliberation and discussion, the En Banc reached a consensus that the extension of service of Commissioner **ERLINDA T. AGUS** will indeed be significant, valuable and indispensable to the Commission as she can still assist the Chairman and the Commission in the attainment of its vision, mission and goals;

**WHEREAS**, the Commission *en banc* unanimously recommended the extension of service of Commissioner **ERLINDA T. AGUS**;

**NOW, THEREFORE, BE IT RESOLVED**, that in view of her meritorious, exemplary and committed service to the NLRC, it is hereby recommended that the services of Commissioner **ERLINDA T. AGUS** be extended by **HIS EXCELLENCY, PRESIDENT RODRIGO ROA DUTERTE**, pursuant to Republic Act No. 9347.


