



MEMORANDUM ORDER NO. 2020-08

CONVERSION OF ACCOUNTANT II AND ACCOUNTANT III POSITIONS OF THE NAYONG PILIPINO FOUNDATION (NPF)

WHEREAS, the NPF requested for the upgrading of the salary grade (SG) of its existing vacant Accountant II (SG 15) position to Accountant II (SG 16) and Accountant III (SG 18) position to Accountant III (SG 19) based on the updated SGs found in the 2018 Index of Occupational Services, Occupational Groups, Classes and Salary Grades (IOS) of the Department of Budget and Management (DBM);

WHEREAS, in the organizational structure and staffing pattern of the approved Rationalization Plan (RP) of NPF, as embodied in GCG Memorandum Order (M.O.) No. 2017-01, the positions of Accountant II and Accountant III bear an SG of 15 and 18, respectively;

WHEREAS, in the Occupational Service of Financial Service of the updated IOS under DBM Budget Circular No. 2018-4, the Accountant II and Accountant III positions are provided with an SG of 16 and 19, respectively;

WHEREAS, the Governance Commission for GOCCs (GCG) pursuant to Republic Act (R.A.) No. 10149 mandates the GCG to “evaluate the performance and determine the relevance of the GOCC, to ascertain whether such GOCC should be reorganized, merged, streamlined, abolished or privatized, ...[and] implement the reorganization, merger or streamlining *unless otherwise directed by the President*;

WHEREAS, the GCG has determined that it is in the best interest of the State to convert NPF’s existing vacant Accountant II (SG 15) position to Accountant II (SG 16) and Accountant III (SG 18) position to Accountant III (SG 19) in accordance with existing government policy;

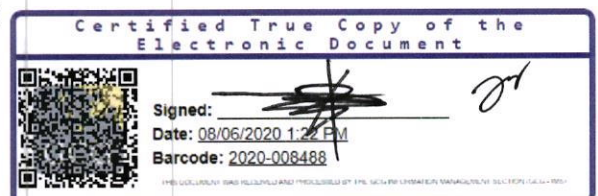
NOW, BE IT –

RESOLVED, that the Accountant II and Accountant III positions of NPF under GCG M.O. No. 2017-01 are hereby **CONVERTED** as follows:

No.	Current Position	SG	Converted Position	SG
1	Accountant II	15	Accountant II	16
1	Accountant III	18	Accountant III	19

RESOLVED FURTHER, that the implementation of this Order shall comply with the following conditions and guidelines:

1. Funds for the purpose shall be taken fully from the corporate funds of the NPF, included in its approved Corporate Operating Budget (COB) as approved by its Governing Board; and



2. The pertinent civil service, budgetary, accounting, auditing and other applicable laws, rules and regulations shall be complied with.
