## COMMISSION EN BANC RESOLUTION NO. 08-020-2020 Series of 2020

"RESOLUTION APPROVING THE AMENDMENTS TO NCIP ADMINISTRATIVE ORDER NO. 01 SERIES OF 2019, OTHERWISE KNOWN AS "RULES ON DELINEATION AND RECOGNITION OF ANCESTRAL DOMAINS AND ANCESTRAL LANDS OF 2019 AND OTHER PROCESSES"

WHEREAS, by virtue of the powers of the NCIP to promulgate rules and regulations for the implementation of R.A. 8371, the Commission En Banc deems it necessary to amend NCIP Administrative Order No. 01, series of 2019, otherwise known as the "Rules on Delineation and Recognition of Ancestral Domains and Ancestral Lands of 2019 and Other Processes" to simplify and expedite the procedure for the recognition and delineation of ancestral domains;

WHEREAS, during the mobile sessions of the Commission last year, concerns were raised by the NCIP Regional Officers and ICCs/IPs Elder/Leaders concerning some provisions of the Administrative Order No. 01, series of 2019 which are purportedly not consistent with the mandate of the R.A 8371 and which cause delays in the delineation process;

WHEREAS, the Commission En Banc carefully reviewed the proposed amendments and finds that it is the best interest of the ICCs/IPs to make the amendments to the Rules on Delineation and Recognition of Ancestral Domains and Ancestral Lands of 2019 and Other Processes that are now contained in the draft copy attached hereto as Exhibit "A",

**NOW THEREFORE**, premises duly considered, on motion duly seconded, be it **RESOLVED** that the proposed amendments in NCIP Administrative Order No. 1 series of 2019, otherwise known as Rules on Delineation and Recognition of Ancestral Domains and Ancestral Lands of 2019 and Other Processes", as contained in Annex "A" hereof are deemed approved.

Let copies of the Resolution and the Rules be furnished to the Office of National Administrative Register (ONAR), UP Diliman, Quezon City for filing, to NCIP Regional Offices, Provincial Offices, Community Service Centers and other concerned governmental agencies.
