**MEMORANDUM CIRCULAR**

**SUBJECT : SUPPLEMENTAL REQUIREMENT FOR UV EXPRESS  
ALLOWED TO OPERATE UNDER MC NO. 2020-025**

---

WHEREAS, on 26 June 2020, the Board issued Memorandum Circular No. 2020-025 setting forth the guidelines for the operations of UV Express during the period of General Community Quarantine (GCQ) in Metro Manila and nearby provinces entering Metro Manila;

WHEREAS, as part of the guidelines for gradual and calibrated opening of routes, select routes have been allowed to resume operations and only those authorized units of said routes are permitted to operate during the period of GCQ;

WHEREAS, in order to properly monitor roadside operations, the Board deemed it fit to issue QR Codes to authorized units that will be allowed to operate during the period of GCQ;

NOW THEREFORE, for and in consideration of the foregoing, and in order to ensure that only authorized units be allowed to operate on the road, the Board hereby sets this additional guideline for UV Express operators on routes allowed to operate under Memorandum Circular No. 2020-025, to wit:

1. Considering that NO SPECIAL PERMIT is necessary, in lieu thereof, the corresponding **QR CODE** shall be issued to the operator. Prior to the resumption of operation per IATF Guidelines, said QR Code shall be downloaded at [www.ltfrb.gov.ph](http://www.ltfrb.gov.ph) and which must be printed by the operator (size : 8.5"x 11" short bond paper) and displayed conspicuously by the operator in the front windshield of authorized unit (without affecting view of the driver).
2. Those UVEs found to operate without the QR Code properly displayed in their units will be apprehended accordingly

The provisions in Memorandum Circular 2020-025 dated 26 June 2020 shall be remain applicable herein.

All issuances inconsistent herewith are hereby superseded and amended accordingly.
