MEMORANDUM CIRCULAR
NO. 2020-038

SUBJECT : ADDITIONAL ROUTES FOR PUBs ALLOWED TO OPERATE DURING THE PERIOD OF GCQ IN METRO MANILA OR ENTERING METRO MANILA

WHEREAS, on 14 May 2020, the Board issued Memorandum Circular No. 2020-019 on the resumption of operations for Public Utility Buses (PUBs) during the period of General Community Quarantine (GCQ) in Metro Manila and those entering Metro Manila;

WHEREAS, pursuant to the guidelines of the Department of Transportation (DOTr) for a gradual and calibrated opening of public transportation in Metro Manila and those in nearby provinces, the Board, through the Franchise Planning and Monitoring Division (FPMD), has since then made the necessary monitoring on the daily operations of the initial routes allowed to operate;

WHEREAS, the FPMD recommended certain PUB routes that need to be opened based on passenger demand;

NOW THEREFORE, for and in consideration of the foregoing, the Board hereby allows **additional PUB routes hereto attached as ANNEX "A"** to operate within Metro Manila and those entering Metro Manila.

The provisions set forth under Memorandum Circular No. 2020-019 dated 14 May 2020 shall be applicable herein. Those interested to operate in any new route shall submit the required documents within five (5) working days from date hereof, and shall undergo the Selection Process per Memorandum Circular No. 2020-019.

All issuances inconsistent herewith are hereby superseded and amended accordingly.




