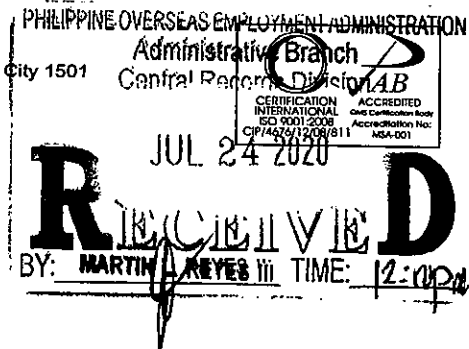

New Entry Measures for Passengers Entering Hong Kong from the Philippines

The Philippine Consulate General in Hong Kong has provided information from the government of Hong Kong about the new entry measures for passengers entering Hong Kong from the Philippines. All passengers must undergo COVID-19 nucleic acid test 72 hours before their flight to Hong Kong. Furthermore, they must also book a hotel to serve as accommodation for the 14-day mandatory quarantine.

Airlines in the Philippines are required to obtain the following documents from passengers as part of check-in requirements:

1. Certification from a laboratory or hospital which contains the HKID or passport number of the passenger and states that the passenger has underwent a SARS-CoV-2 nucleic acid test and has obtained a negative result. This certification is attached as Form A.
2. Certification from a concerned Philippine agency which recognizes and approves the abovementioned laboratory or hospital. This certification is attached as Form B.
3. Original copy of the SARS-CoV-2 test result from the laboratory or hospital which contains the ID or passport number of the passenger.
4. Proof of hotel booking not less than 14 days starting from arrival in Hong Kong.

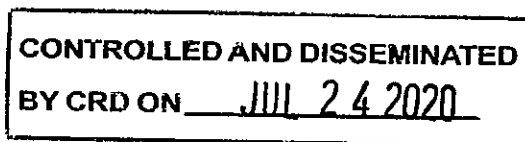
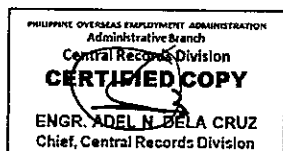
According to the Hong Kong Labour Department, the workers' employers shall shoulder the costs of testing and hotel booking.

The new measures will come into effect at 12:00 AM, 25 July 2020. These measures do not apply to transiting passengers.

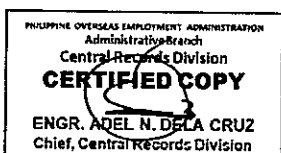
