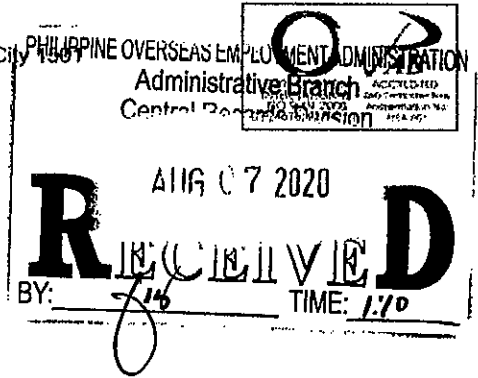

**Resumption of Commercial Flights in Kuwait  
with Select Temporary Suspension**

The Directorate General of Civil Aviation of the State of Kuwait has announced the resumption of commercial flights in Kuwait beginning on 01 August 2020.

In connection thereto, all passengers arriving and departing from the Kuwait International Airport must adhere to the following guidelines:

**For Departures:**

1. Download and register the application Kuwait Musafir/Kuwait Traveler which is available in English and Arabic from the website [www.kuwaitmosafer.com](http://www.kuwaitmosafer.com);
2. Obtain a health certificate issued by laboratories accredited by the Ministry of Health proving the negative result of COVID-19 if necessary, according to the requirements of the country of destination;
3. Citizens must obtain travel health insurance that covers the treatment for COVID-19; and
4. Adhere to health requirements in terms of wearing masks and gloves, use of sterilizers and adherence to social distancing.

**For Arrivals:**

1. Obtain an accredited health certificate Polymerase chain reaction (PCR) proving the negative result of COVID-19 with a validity period of 96 hours from the date of examination;
2. Download and register on "Shlonik" application before boarding the plane;
3. Home quarantine for 14 days;
4. Check temperature of all passengers before boarding and upon arrival;
5. Random PCR test on 10% passengers upon arrival per flights; and
6. Adhere to health requirements in terms of wearing masks and gloves, use of sterilizers and adherence to social distancing.


