**EN BANC RESOLUTION NO. 07-20**

**WHEREAS**, based on the statistics of the NLRC Research, Information and Publications Division (NLRC RIPD), there are Regional Arbitration Branches (RABs) which need additional Labor Arbiters based on inflow of cases;

**WHEREAS**, the lack of Labor Arbiters in the said RABs should be immediately addressed in order to comply with the NLRC's commitment of speedy resolution of cases;

**WHEREAS**, there are RABs with vacant Labor Arbitrator plantilla positions but do not require additional Labor Arbiters as the existing complement is sufficient to handle their present caseload;

**WHEREAS**, in the exigency of the service, there is now a need to rationalize the assignment and deployment of Labor Arbiters in RABs where their services are needed;

**WHEREFORE, RESOLVED AS IT IS HEREBY RESOLVED** that the following plantilla items shall be ASSIGNED to the following Regional Arbitration Branches where services of Labor Arbiters are urgently needed:






