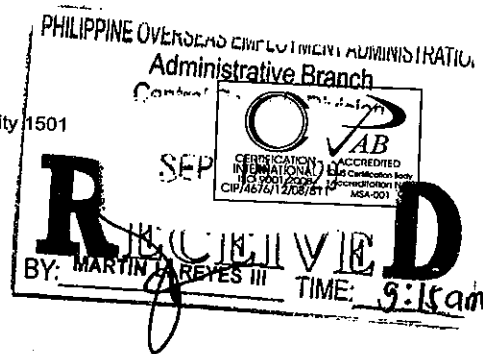

**COVID-19 Testing for Seafarers on Vessels from the Philippines  
Bound for South Korea**

The Embassy of the Republic of Korea in the Philippines has issued a notice reminding seafarers departing from the Philippines to present a PCR certificate issued by embassy-designated hospitals within 48 hours of departure date and submit it when entering South Korea. The list of embassy-designated hospitals is attached and is also available in the embassy's website.

The measures above are being implemented in connection with the cases of violation in the submission of PCR certificates submitted by the seafarers. As such, the Korean Centers for Disease Control and Prevention (KCDC) will take the following measures effective September 8th on the following violations:

- Submission of PCR certificates where issuance date is over 48 hours before the departure date;
- Submission of PCR certificates issued by non-designated hospitals;
- Submission of forged, altered or fake PCR certificates;
- non-submission of PCR certificates.

**Penalties:**

- Seafarers who violate the regulations would be incarcerated for up to 1 year or fined up to 10 million won.
- Restriction of future entry of ships that have been charged of the violations mentioned above.

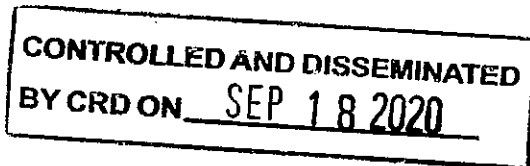
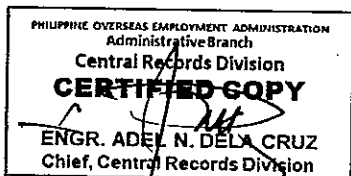
