MEMORANDUM CIRCULAR NUMBER 2020-067

SUBJECT: PARTIAL LIFTING OF SUSPENSION UNDER MC 2016-012

WHEREAS, on September 1, 2016, the Board has issued Memorandum Circular No. 2016-012 (Re: AMENDMENT TO MEMORANDUM CIRCULAR NO. 2016-008), which placed under moratorium the acceptance of TNVS Applications nationwide;

WHEREAS, on January 18, 2018, the Board has issued Memorandum Circular No. 2018-003 setting the Common Supply Base for TNVS which included Metro Manila (including MUCEP area), Metro Cebu and Pampanga;

WHEREAS, in said MC No. 2018-013, common supply base for other urbanized areas, shall be subsequently issued by the Board when necessary;

WHEREAS, reports and communication from LTFRB Regional Office VI relative to the existence of colorum vehicles have been validated through the apprehension of vehicles from sedans to high end SUVs operating as Transportation Network Vehicle Services (TNVS) in Bacolod City;

WHEREAS, from the data of Regional Franchising and Regulatory Office (RFRO) VI, there is an indication of public necessity for such type of service in Bacolod City area;

WHEREAS, the Board after review and evaluation of the circumstances surrounding the effect of suspending the acceptance of application for TNVS vis-à-vis the presence of *colorum* vehicles operating as TNVS, has agreed to partially lift the suspension imposed under MC No. 2016-012;

NOW THEREFORE, for and in consideration of the foregoing, the Board hereby RESOLVES to PARTIALLY LIFT the Suspension of Acceptance of Application for Issuance of Certificate of Public Convenience to Operate TNVS, and ALLOWS Acceptance of TNVS Applications within Bacolod City and nearby cities and municipalities in Negros Island for a total of one hundred fifty (150) units.

Accordingly, the RFRO VI is hereby ordered to comply with the existing issuances of this Board relative to the policies and guidelines, process, specifications and standards, and operating conditions for TNVS,

All other issuances or parts thereof inconsistent herewith are hereby modified, amended, or superseded accordingly.
