**MEMORANDUM CIRCULAR**  
NO. 2020- 072

**SUBJECT : CLARIFICATION ON SELECT ROUTES PER MC 2020-025 AND MC NO. 2020-062**

**WHEREAS**, pursuant to the guidelines of the Department of Transportation (DOTr) for a calibrated and gradual opening of public transportation in Metro Manila and those in nearby provinces, the Board has since then made the necessary monitoring on the daily operations of the initial routes allowed to operate;

**WHEREAS**, on 26 June 2020, the Board issued Memorandum Circular No. 2020-025 on the resumption of operations for UV Express units starting 03 July 2020 during the period of General Community Quarantine (GCQ) in Metro Manila and entering Metro Manila which included as part of Annex "A" the route: STO. NIÑO, MEYCAUAYAN – CENTAL INTEGRATED TERMINAL(CIT);

**WHEREAS**, on 21 October 2020, the Board issued Memorandum Circular No. 2020-062 opening several UV Express Routes in Metro Manila and entering Metro Manila which included the routes: (1) MALOLOS, BULACAN TO QUEZON AVENUE; and (2) STO. NINO, MEYCAUAYAN - QUEZON AVENUE in the list marked as Annex "A";

**WHEREAS**, upon review of the said routes, it appears that there has been a discrepancy in the original point of destination involving the CIT;

**WHEREAS**, further review of said MCs also showed that the Quezon Avenue should have been identified as the modified end point, and which needs to be clarified to avoid confusion;

**NOW THEREFORE**, for and in consideration of the foregoing, the Board hereby clarifies the two routes mentioned under MC No. 2020-025 and MC No. 2020-062 to read as follows:

MC 2020 – 025 and MC 2020 – 062 are hereby modified, amended, or superseded accordingly.
