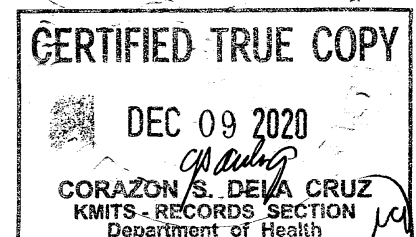
FROM : Deferment of Validated Electronic Health/Medical Record System as Licensing Requirement

Pursuant to Department Circular (D.C.) No. 2020-0037, known as “Guidelines in the Submission of the Hospital Statistical Report thru the Online Health Facility Statistical Reporting System (OHFSRS),” post-licensing inspection/monitoring to check for the validated Electronic Health/Medical Record System (EHR/EMR) should have commenced last April 2020.

However, due to the pandemic, Department of Health (DOH) issued Department Memorandum (D.M.) No. 2020-0119 known as “Suspension of the NEHEHRSV Operations in DOH Central Office, CHDs, Metro Manila, CALABARZON and MIMAROPA,” and D.M. No. 2020-0371 titled “Resumption of the National eHealth Electronic Health/Medical Record System Validation Operations in Selected Regions.” Prior to suspension of the validation operations, only 52 % (651 out of 1,260) of hospitals have validated EHR/EMR.

In view of the above, the following guidelines shall be followed:

1. The License to Operate (LTO) of hospitals without a validated EHR/EMR shall be renewed for 2021, provided that they have no sanctions or corrective actions still for compliance. Moreover, absence of validated EHR/EMR shall not be considered as a violation during the 2021 monitoring activities.
2. Hospitals already with validated EHR/EMR shall continue using the system to input their daily data.




3. The deadline for submission of the 2020 Annual Hospital Statistical Report is on March 31, 2021.
 - a. Hospitals with a validated EHR/EMR shall transmit their 2020 Statistical Report using the validated system.
 - b. Hospitals without a validated EHR/EMR shall encode the 2020 annual hospital statistical report through the Online Health Facility Statistical Reporting System (OHFSRS) website (<http://ohrs.doh.gov.ph>).
4. Submitted statistical reports for years 2016, 2017, 2018 and 2019 will still be accessible for encoding and monitoring of the revised and corrected data.
