MEMORANDUM CIRCULAR NUMBER 2020 - 082

Subject: RESUMPTION OF POINT TO POINT (P2P) PROVINCIAL OPERATIONS

WHEREAS, the Land Transportation Franchising and Regulatory (LTFRB) was created by virtue Executive Order No. 202 dated June 19, 1987, as administrative agency with quasi-judicial powers, and is the existing franchising and regulatory body for land transportation today;

WHEREAS, pursuant to the guidelines of the Department of Transportation (DOTr) for a calibrated and gradual opening of public transportation, the Board has since then made the necessary monitoring on the daily operations of the initial routes allowed to operate;

WHEREAS, Board Resolution No.153, Series of 2020 dated August 5, 2020 was issued by the Board, which sets and adopts guidelines in the operation of Point to Point (P2P) Series during the period of General Community Quarantine;

WHEREAS, on 25 September 2020, the Board issued Memorandum Circular No. 2020-051 which allowed the resumption of operations of select Provincial Bus routes entering Metro Manila, and under Item II thereof, the Board may issue additional routes to resume operations upon approval and coordination with the concerned Local Government Unit (LGU);

whereas, taking into account the issuance of the Board Resolution and Memorandum Circular stated in the immediately preceding whereas clauses, the same resumption of operations should be extended to P2P Provincial Bus routes entering or not entering Metro Manila;

WHEREAS, in its meeting on 14 December 2020, the Inter-Agency Task Force on Emerging Infectious Diseases (IATF-EIF) approved IATF Resolution No. 88 Series of 2020 the resumption of Point to Point (P2P) provincial buses, and will be given unhampered travel through all the Local Government Units (LGUs) they will be passing, to their final destination.

NOW THEREFORE, for and in consideration of the foregoing, the Board hereby allows the routes (attached as ANNEX "A") for Point to Point Provincial Buses entering or not entering Metro Manila starting 18 December 2020 subject to the following conditions:

COVERAGE - Only P2P Provincial Buses with Certificate of Public Convenience, and those with Provisional Authority and Special Permit prior to the implementation of quarantine restrictions on 16 March 2020 with pending Applications for Certificate of Public Convenience to Operate P2P service are allowed to resume operations subject to the conditions provided under Board Resolution No. 067, Series of 2020 and Memorandum Circular No. 2020-061.

For inter-regional/inter-provincial travels, the LGUs concerned are given the discretion to prescribe their respective protocols. Under Annex "A" hereof is the list of P2P Provincial Bus routes to resume operation. Authorized units, either by Decision approving the Certificate of Public Convenience, Provisional Authority or Special Permit for Interim Operations, on the routes identified to resume operations shall be issued corresponding Special Permit. The units allowed to resume operations and travel shall be subject to LGU and IATF guidelines;

- 2. Endpoint Terminals are compliant to anti-COVID 19 measures pursuant to Board Resolution No. 153, Memorandum Circular No. 2020-005, as inspected and confirmed/concurred by RFROs:
- 3. Passenger will subscribe to the endpoint LGU-prescribed health protocol.

All issuances inconsistent herewith are hereby superseded and amended accordingly.

This Memorandum Circular shall take effect immediately following its publication in a newspaper of general circulation and filing of three (3) copies hereof with the Office of the National Administrative Register (ONAR) of the UP Law Center pursuant to Presidential Memorandum Circular No. 11 dated 9 October 1992.
