PROCLAMATION NO. 1248

DECLARING THE SECOND WEEK OF MARCH OF EVERY YEAR AS "BANKERS INSTITUTE OF THE PHILIPPINES (BAIPHIL) TRAINING AND DEVELOPMENT WEEK"
