ORDINANCE NO. 316 Series of 2021

Sponsored by: The Joint Committees on Budget and Appropriations, and Personnel and Policies

AN ORDINANCE AMENDING SECTION 5 OF PROVINCIAL ORDINANCE NO. 304, SERIES OF 2020

WHEREAS, Provincial Ordinance No. 304, Series of 2020 prescribed the rates for workers hired on Job Order status in construction sector and the minimum wage earners of the Provincial Government of Batanes;

WHEREAS, Section 5 of Ordinance No. 304, Series of 2020 authorized the increase of minimum wage of emergency employees performing clean and green activities and office helpers from PhP250.70/day to PhP300.00/day;

WHEREAS, the Provincial Governor in her letter dated December 23, 2020 requested the Sangguniang Panlalawigan to differentiate the rates for emergency employees or office helpers at PhP300.00/day and clean and green laborers at PhP250.70/day;

WHEREAS, the minimum wage earners could hardly cope up with the high cost of living at a rate of Php250.70 daily wage, hence this Sanggunian has considered to increase the minimum wage from the proposed PhP250.70 to PhP270.00/day;

NOW THEREFORE, on motion of Hon. Juan E. Redondo duly seconded by all the Honorable Sangguniang Panlalawigan Members present.

BE IT ORDAINED by the Sangguniang Panlalawigan of Batanes in session duly assembled that:

SECTION 1. The Amendment. Section 5 of Provincial Ordinance No. 304, Series of 2020 is hereby amended as follows:

SECTION 5. The Minimum Wage Rate for Emergency Employee is hereby authorized and categorized as follows:

SECTION 2. Addendum Definition for clarity.

Job Order – refers to the hiring of a worker for piece work or intermittent job of short duration not exceeding six months and pay is on a daily or hourly basis. It is to be understood that the piece work or job to be performed requires special or technical skills not applicable in the agency and the same is to be accomplished under the worker's own responsibility and with minimum supervision by the hiring agency.





SECTION 2. Separability Clause. If any provision of this Ordinance is declared unconstitutional, the same shall not affect the effectivity of the other provisions hereof.

SECTION 3. Repealing Clause. Any Ordinances and executive orders inconsistent herewith shall be deemed superseded and/or repealed accordingly.

SECTION 4. Effectivity. This Ordinance shall take effect upon approval.

AN ORDINANCE CREATING PLANTILLA POSITIONS OF LOCAL LEGISLATIVE STAFF OFFICER II, LOCAL LEGISLATIVE STAFF OFFICER I, AND ADMINISTRATIVE ASSISTANT V IN THE LEGISLATIVE DEPARTMENT OF THE PROVINCE OF BATANES AND PROVIDING FUNDS THEREFOR

WHEREAS, the Office of the Vice Governor proposed for the creation of new plantilla positions to supplement the Sanggunian's manpower requirements to implement effectively and efficiently its mandate;

WHEREAS, the above proposed positions for creation are applicable to LGUs and are found in the Index of Occupational Services (IOS) prescribed in Local Budget Circular no. 65, dated March 18, 1996 of the Civil Service Commission (CSC);

WHEREAS, the general limitations on Personal Services expenditures in the Fiscal Year 2021 Annual Budget is not exceeded;

WHEREAS, all mandatory positions provided under R.A. 7160 have been created and provided in the Annual Budget of the province; and

WHEREAS, it is within the prescribed powers of the Sangguniang Panlalawigan to determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from provincial funds for the proper conduct of programs, projects, services, and activities of the provincial government pursuant to Section 468 (viii) of the Local Government Code of 1991.

NOW THEREFORE, be it ORDAINED by the SANGGUNIANG PANLALAWIGAN OF BATANES, that:

Section 1. CREATION: There shall be created plantilla positions with corresponding Salary Grades in the Legislative Department as follows:

Section 2. QUALIFICATIONS: The qualifications for the respective positions created shall be governed by the pertinent provisions of Memorandum Circular No. 1, series of 1997 (Qualification Standards) issued by the Civil Service Commission (CSC) on January 24, 1997, and other new applicable rules and regulations that the Commission may promulgate.

Section 3. FUNCTIONS, DUTIES AND RESPONSIBILITIES: The Provincial Human Resources Management and Development Office (PHRMDO) in coordination with the Secretary to the Sanggunian shall be responsible to define the duties and functions appropriate to the positions created which shall be contained in the position descriptions of the appointee for approval of the Local Vice Chief Executive or his duly authorized representative.

Section 4. FUNDING: The funding requirements corresponding to the positions created is hereby authorized to be appropriated from available funds certified by the Provincial Accountant and the Provincial Treasurer, in the Supplemental Budget of the province for Fiscal Year 2021 and Annual Budgets thereafter. The budgetary appropriations shall be provided in accordance with the prescribed policies, standards and rules on compensation and position classification in LGUs issued by the Department of Budget and Management (DBM), and other pertinent laws.

Section 5. EFFECTIVITY: This ordinance shall take effect upon its approval.
