1. Ordinance No. 2021-324 - An Ordinance Approving the Realignment of Two Million Five Hundred Thousand Pesos Allocated for the Rehabilitation of Itbayat Municipal Streets under the CY 2021 20% Development Fund of the Province to the Improvement/Upgrading of Water Works System of the Municipality of Itbayat

SECTION 3. REALIGNMENT OF FUNDS. This Ordinance hereby authorizes the realignment of Two Million Five Hundred Thousand Pesos (P2,500,000.00) initially allocated for the Rehabilitation of Itbayat Municipal Streets under the CY 2021-20% Development Fund of the Province of Batanes to the Improvement/Upgrading of Water Works System of the Municipality of Itbayat.

SECTION 4. POLICY UTILIZATION GUIDELINES. The policy guidelines in the utilization of the funds shall be made in accordance and consistent with DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020 revising the guidelines on appropriation and utilization of the 20% of the Internal Revenue Allotment (IRA) for development projects, DBM-DILG JMC 2020-001 and other new applicable rules and regulations in the utilization of the 20% Development Fund.

SECTION 5. For the LGU of Itbayat and Provincial Government through the Provincial Development Council to adjust the existing AIP for the specific item appropriation to conform if not exceed the re-aligned budget that includes the existing budget through a supplemental investment plan.

SECTION 6. For the LGU of Itbayat or the Provincial Engineering Office (PEO) to provide a copy to the Sanggunian of their Comprehensive Municipal Waterworks Rehabilitation/Development Plan to support funding requirement.

SECTION 7. DISBURSEMENT OF FUNDS. Disbursement of funds shall be made subject to the usual government budgeting, accounting, and auditing rules and regulations.

SECTION 8. FISCAL RESPONSIBILITY. Fiscal responsibility shall be shared by all those exercising authority over the financial affairs, transactions and operations of the Provincial Government subject to the provisions of Section 342 of the Local Government Code of 1991.

SECTION 9. SEPARABILITY CLAUSE. If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional by a competent court of jurisdiction other section or provisions thereof which are not affected thereby shall continue to be in full force and effect.

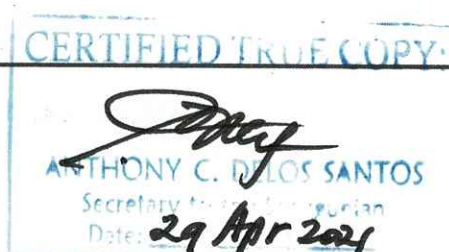
SECTION 10. EFFECTIVITY. This Ordinance shall take effect upon its approval.
