

PHLPOST ADMINISTRATIVE ORDER NO. 21-04



SUBJECT: SURCHARGES ON POSTAGE RATES FOR DOMESTIC PARCEL SERVICE

Pursuant to PHLPost Board Resolution No. 2020-55 dated 16 September 2020 and due to the increase in conveyance costs brought by COVID-19 Pandemic, surcharges on the published Postage Rates for Domestic Parcel Services shall be implemented at all Post Offices/counter Acceptance Offices, effective immediately, as follows:

(Ex: From any point of Luzon to Vis/Min, Palawan, Batanes, San Jose Occ. or vice versa)

Clients with existing Memorandum of Agreement (MOA) or that have been granted special discounts prior to effectivity of this Administrative Order shall continue to avail of the agreed rate until the expiration of the contract/agreement.

Issuances not in accordance herewith are hereby amended/revoked accordingly.

PHLPost EXECOM RESOLUTION NO. 2020 - 33 20 August 2020

Subject

: Surcharge for Domestic Mails (Ordinary, Registered, Express & Parcel)

WHEREAS, the imposed lockdowns and restriction of movement to prevent the spread of the corona virus has significantly affected the delivery of mail matters;

WHEREAS, domestic dispatches were suspended due to the temporary closure of airports/ seaports and the non-availability of airline/ shipping services;

WHEREAS, disruption in the aviation/ shipping industry caused a dramatic increase in the conveyance of domestic mails;

WHEREAS, the Chairman of the Costing and Pricing Committee is proposing the imposition of temporary surcharges for domestic mails to cover the increase in conveyance.

HERETO, RESOLVED, that the PHLPost Executive Committee recommends for approval of the PHLPost Board of Directors the proposed imposition of temporary surcharge for domestic mails.

THAT, upon approval of the Board of Directors, the Chairman of the Costing and Pricing Committee is directed to finalize the rate matrix for the temporary surcharge for Domestic Mails and draft a Circular for signature of the Postmaster General and CEO and to be issued for the information and guidance of all concerned PHLPost employees and the mailing public.
