AN ORDINANCE AMENDING SPECIFIC PROVISIONS OF SECTION 1, 2 AND 3 OF PROVINCIAL ORDINANCE NO. 321 SERIES OF 2021 AUTHORIZING THE EARTHQUAKE FUND DONATIONS IN THE AMOUNT OF Php1,691,427.41 FOR THE PROCUREMENT OF CONTAINER PLASTIC DRUMS FOR DISTRIBUTION TO EVERY HOUSEHOLD IN ITBAYAT BATANES

WHEREAS, last March 8, 2021, the Provincial Governor through an Endorsement Letter No. 11 requested for an authority to allocate the amount of One Million Six Hundred Ninety One Thousand Four Hundred Twenty Seven Pesos and Forty One Centavos (Php1,691,427.41) from Earthquake Fund Donations for the procurement of double ring drums to be distributed to each and every household who suffers from lack of water or weak water pressure from their faucets due to the destructions brought about by the twin earthquake in the island Municipality of Itbayat in year 2019;

WHEREAS, this Sanggunian granted the authority by enacting Provincial Ordinance No. 321, Series of 2021 on March 23, 2021;

WHEREAS, during the procurement period, an endorsement letter No. 18, dated April 27, 2021 was issued again by the Provincial Governor urgently requesting the August Body to amend abovementioned Ordinance No. 2021-321 to remove the specification of "**double ring**" and simply replaced it with "**plastic drums with at least 200 liters capacity**" due to lack of stocks following the former specification; and,



WHEREAS, considering that the island municipality is currently declared under State of Calamity due to severe water crisis brought about by the prolonged dry spell, there is an urgent need to provide them containers where they may store their water supply from time to time;

NOW THEREFORE, BE IT ORDAINED by the SANGGUNIANG PANLALAWIGAN of the Province of Batanes, that:

SECTION 1 SHORT TITLE: This Ordinance shall be known as "**Amendatory Ordinance to Provincial Ordinance No. 321, Series of 2021**".

SECTION 2. AMENDMENTS: Sections 1, 2 and 3 of Provincial Ordinance No. 321, Series of 2021 are hereby amended to read as follows:

Section 1. Title. The title of the Ordinance shall be known as "An Authorization of Earthquake Fund Donations in the Amount of One Million Six Hundred Ninety-One Thousand Four Hundred Twenty-Seven Pesos and Forty-One Centavos (PhP1,691,427.41) for the procurement of plastic drums with at least 200 liters capacity for distribution to each and every household in the Municipality of Itbayat".

Section 2. Purpose and Objective. The purpose and objective is to expedite the procurement of plastic drums with at least 200 liters capacity as water containers for immediate distribution in order to mitigate the effects of water crisis.

Section 3. Authorization of Funds. This Ordinance hereby affirms the authorization of Fund Donations in the Amount of One Million Six Hundred Ninety-One Thousand Four Hundred Twenty-Seven Pesos and Forty-One Centavos (PhP1,691,427.41) for the procurement of plastic drums with at least 200 liters capacity for distribution in the Municipality of Itbayat.

SECTION 3. REPEALING CLAUSE: All provisions or parts of Ordinance No. 321, Series of 2021 which are inconsistent with any amendments provided in this Ordinance are hereby repealed or modified accordingly.

SECTION 4. EFFECTIVITY: This Ordinance shall take effect upon its approval.

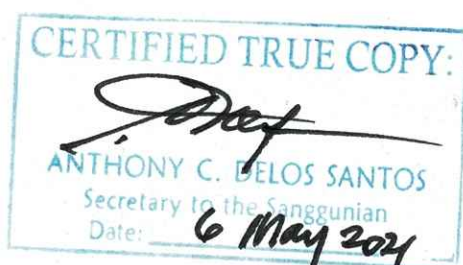

AN ORDINANCE FURTHER AMENDING SECTION 1 OF ORDINANCE NO. 273, SERIES OF 2019 DECLARING THE PROVINCIAL GOVERNMENT COMMUTER VAN (TOYOTA HI-ACE WITH PLATE NO. VY-8134) AS EMPLOYEE SERVICE VEHICLE

WHEREAS, on November 13, 2017, Provincial Ordinance No. 244, Series of 2017 was enacted to declare the Provincial Commuter Van with Plate No. VY-8143 as an employee service vehicle prescribing reasonable fare rates and for other related purposes which was subsequently amended by Provincial Ordinance No. 273, series of 2019 on April 8, 2019;

WHEREAS, the Provincial Governor through an Endorsement Letter No. 14 dated April 5, 2021 requested to further amend above mentioned Ordinances to authorize the inclusion of National Government Agency employees whose offices are located in the southern municipalities as passengers during inclement weather;

WHEREAS, this is also to maximize and ensure that the service vehicle will also earn to cover the fuel costs to and from the southern municipalities;

NOW THEREFORE, BE IT ORDAINED by the SANGGUNIANG PANLALAWIGAN of the Province of Batanes, that:

SECTION 1. AMENDMENT. This Ordinance hereby furtherly amends Section 1 of Provincial Ordinance No. 273, series of 2019 to read as follows:

Section 1. DECLARATION OF POLICY. Pursuant to Section 154 (Operation of Public Utilities) of the Local Government Code of 1991, the Provincial Government's 2016 Toyota Hi-Ace commuter van with Plate No. VY-8134 is hereby declared as General Service Vehicle. It can be used as an employee service vehicle or it can be rented out subject to the reasonable rates prescribed or that may be prescribed in the future. This is in addition to its use as service vehicle by the Provincial Government for official business. Furthermore, this is to authorize the inclusion of National Government Agency employees assigned in the offices located in the southern municipalities as passengers during inclement weather.

SECTION 2. PURPOSE AND OBJECTIVE. The purpose and objective of further amending such Ordinance is to accommodate the national government agency employees as passengers during inclement weather and to maximize and ensure that the service vehicle will also earn income to cover the fuel costs and its maintenance.

SECTION 3. REPEALING CLAUSE. Any provisions of Provincial Ordinance No. 244, Series of 2017 and Ordinance No. 273, Series of 2019 or part thereof in conflict or inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon its approval.


