## CIRCULAR LETTER NO. CL-2021-037

## To : All BSP-Supervised Financial Institutions (BSFIs)

## Subject : Advisory on Electronic Sabong (eSabong)

The Philippine Amusement and Gaming Corporation (PAGCOR) recently adopted a Regulatory Framework for eSabong. eSabong is defined as the online/remote or off-site wagering/betting on live cockfighting matches, events, and/or activities streamed or broadcasted live from cockpit arena/s licensed or authorized by the Local Government Units having jurisdiction thereof. Online sabong or eSabong is regulated by PAGCOR pursuant to its Charter as clarified by the Office of the Solicitor General and the Department of Justice<sup>1</sup>.

Among the key features of the framework are the following:

- a. Operator licensing process and requirements;
- b. Platform requirements and standards;
- c. Know Your Customer, Verification and Monitoring of players;
- d. Account Funding and Withdrawal through AMLC-compliant channels;
- e. Prohibition for offshore bets and streaming;
- f. Registration process for agents, coordinators, promoters;
- g. Reporting obligations; and
- h. Compliance with all Anti-Money Laundering and Countering the Financing of Terrorism (AML/CFT) Laws, Rules and Regulations issuances of the Anti-Money Laundering Council, PAGCOR and other relevant government agencies, including but not limited to Republic Act No. 10927, an Act Designating Casinos as Covered Persons under RA 9160, as amended, and its Casino Implementing Rules and Regulations; AML/CFT Guidelines for Casinos; and Customer Due Diligence Guidelines for Land-based Casinos.

As previously communicated in Circular Letter No. 2021-012 dated 6 February 2021, BSFIs shall deal only with gambling and/or online gaming businesses that are authorized/licensed by or registered with the appropriate government agency and BSFIs are mandated to strictly adhere with the requirements under Part Nine of the Manual of Regulations for Banks and Manual of Regulations for Non-Bank Financial Institutions and the BSP Memorandum No. 2018-002<sup>3</sup> dated 17 January 2018.
