**PRESCRIBING THE MINIMUM TECHNICAL SPECIFICATIONS
 FOR THE AMENDED OFFICIAL SEAL/LOGO FOR
 REGIONAL MOBILE FORCE BATTALION 4A**

1. REFERENCES:

- a. Uniform Equipment Standardization Board (UESB) Resolution No. 2021-03-017 dated March 18, 2021, entitled: "Approving the Proposed Official Seal/Logo for RMFB4A";
- b. Memorandum from TADR D dated October 28, 2020, with subject: "Reiteration on the Submission of the Proposed Unit Seal/Logo for PPOs, CPOs, RMFBs, PMFCs and CMFCs"; and
- c. Memorandum from TDR D dated April 29, 2011, with subject: "Guidelines in Proposing Unit Seal/logo for PPOs, CPOs, RPSBs, PPSCs, and CPSCs".

2. RATIONALE:

This Memorandum Circular (MC) sets forth the minimum technical specifications for the Official Seal/Logo for Regional Mobile Force Battalion 4A (RMFB4A) to be used as an office marker and patch for General Office Attire (GOA) and Field Service Uniform (FSU) of the uniformed personnel of the Philippine National Police (PNP).

3. SITUATION:

The official seal/logo for Regional Public Safety Battalion 4A (RPSB4A) was approved by the UESB on September 26, 2017 under its Resolution No. 2017-044 entitled: "Approving the Proposed Official Seals/Logos for RPSB4A, Batangas PPO, Cavite PPO, Laguna PPO, and Quezon PPO.

On October 16, 2017, PNP MC No. 2017-063, entitled: "Amending NHQ-PNP Memorandum Circular No. 2009-020A dated July 5, 2010 entitled: "Guidelines and Procedures on the Rationalization of the PNP Mobile Groups"" was approved wherein the term Regional Public Safety Battalion (RPSB) was renamed to Regional Mobile Force Battalion (RMFB).

On March 18, 2021, during the UESB meeting, the renaming of the name/nomenclature "RPSB4A" to "RMFB4A" was approved under UESB Resolution No. 2021-03-017 in order to be consistent with the approved MC.

4. PURPOSE:

To provide and establish the minimum technical specifications for the Official Seal/Logo of RMFB4A which will be used as its official marker and in the patch for GOA and FSU of PNP uniformed personnel.

5. DEFINITION OF TERMS:

For purposes of this MC, the following terms shall mean:

- a. **Logo** – refers to the graphic mark, emblem, or symbol used to aid and promote public identification and recognition. It may be of an abstract or figurative design or includes the text of the name it represents as in a wordmark.
- b. **Regional Mobile Force Battalion (RMFB)** – formerly named as Regional Public Safety Battalion (RPSB). It refers to a battalion-size mobile reaction unit of a Police Regional Office for internal security operations and to reinforce/support the provincial, city, and municipal police units for public safety operations, law enforcement operations, and special police operations.
- c. **Symbol** – shall mean any conventional sign which reveals man's achievement and heroism (for medals, orders, and decorations), identification of authority, and a sign of dignity (for coat-of arms, logo and insignia).
- d. **Technical Specifications** – refer to the physical description of the goods or services as well as the procuring entity's requirements in terms of the functionality, performance and standard designs of the goods to be manufactured or supplied, and/or the services to be rendered.

6. PROPER WEARING/USE:

- a. **WHO WILL WEAR:** All PNP uniformed personnel who are assigned to RMFB4A.
- b. **WHEN TO WEAR/USE:**
 - 1) **PNP Uniformed Personnel:** When wearing GOA and FSU.
 - 2) **Office/Document:** As an official marker/logo.
- c. **WHERE TO PUT:**
 - 1) **Patch:** As prescribed in the uniform.
 - 2) **Office Marker/Logo in the Document:** As prescribed.

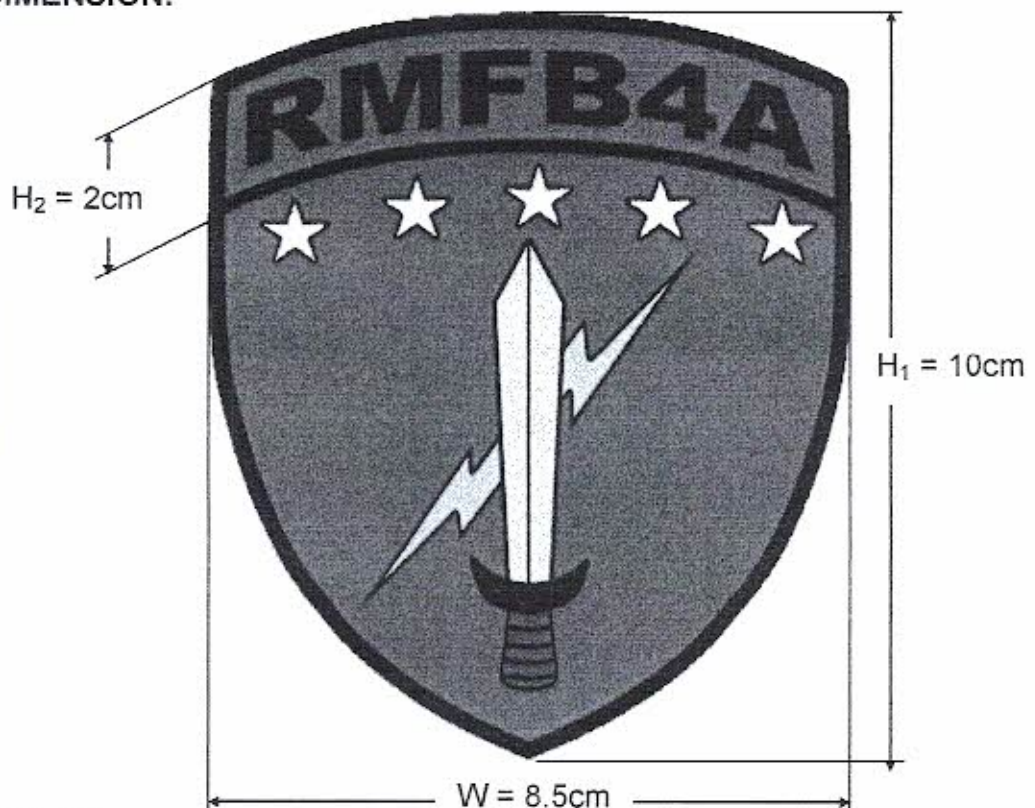

- The word "RMFB4A": Font = Arial, Height of Font = 1.0cm, and Height of Background (H_2) = 2cm
