About

The UP College of Law Scholarship Program is intended to provide financial assistance to economically disadvantaged students who need it the most.

It was initiated in the first semester of academic year 2019-2020 when the College decided to formulate its own Scholarship Program from the old scheme of bridging various private scholarship options with students at the UP College of Law. Now, the UP College of Law pools funds from various private donors and in turn, accepts application from students who may qualify to be recipients of the scholarship program.

Applying students may qualify to be part of one of the three tiers introduced by the College according to various financial factors set by the College with the following benefits:

> Tier 1 - Full waiver of tuition fee, book allowance, and monthly allowance

> Tier 2 - Full waiver of tuition fee and book allowance

Tier 3 - Full waiver of tuition fee

History

The total tuition and other fees at the UP College of Law are estimated to cost around P27,000 per semester. In 2018-2019, the College had a total of 1,014 enrollees across all year levels. Of the 1,014, 411 students—comprising 40.5% of the student population-applied for student fee discounts under the Socialized Tuition System (STS). The STS offers a graduated tuition discount system based on income and socioeconomic characteristics of the applicant's household.

Due to the stringent requirements of the STS, however, many applications from students of the College are denied. During the same school year, there were 8 applications for leave of absence which specified financial need as reason.

This problem was amplified by the pandemic. The shift to remote learning posed challenges that compounded the already existing problems which financially handicapped students were facing.

Under the previous scholarship regime, the College administered 30 programs, all of which were established from private funds or periodic donations.

Under this scheme, the donors themselves specify the amount of the fund or donation, as well as the criteria for the selection of the scholar. The College implements the instructions from the donors and recommends qualified applicants therefor.

Due to this, scholarships that require minimum grades, or a particular gender, home province, family background, and low income threshold—coupled with high merit requirements—are usually without a matched scholar. Financially handicapped applicants are unable to avail themselves of scholarship grants due to rigid and multiple criteria imposed.



To address this problem, changes to the scholarship program were introduced starting AY 2019-2020, which aimed for the College to establish its own scholarship fund from donations from alumni and other parties, including the pooling, whenever proper, of the private scholarship funds.

Doing so allowed the College to establish its own scholarship fund, subject to its own policies and guidelines in terms of management and disbursement and criteria for scholars. The inability of many deserving applicants to obtain financial grants due to stringent and multiple criteria has thus been addressed, and the processing of the applications and payment of the grants have been simplified.

The current iteration of the scholarship program introduced a mode of renewal which allows students who qualified in the previous semester to renew by the mere expedient of submitting a letter of intent. Previously, students were required to go through the whole application process per semester.

In the academic year 2018-2019, there were a total of 59 grantees across various scholarships, in varying amounts and subject to various qualifying criteria. Upon the implementation of the UP College of Law Scholarship Program, this number has been increased to 72 in A.Y. 2019-2020, to 145 in A.Y. 2020-2021, and to 159 in A.Y. 2021-2022.



At present, the program supports a total of 127 scholars, all of whom are selected on the basis of uniform criteria, and given grants based on a multitiered system.





The only difference is that my parents have also become dependent on us during this law school. They have since retired and the typical Filipino setup obligates us to support them. This adds a burden on my financial standing.

Had I not been part of the scholarship program, I would have already been moving mountains to raise funds for my tuition. Paying tuition might already mean depriving my family of the help I should be giving to them. I find it unfair to prioritize my legal education over their needs.

With the assistance that the College has extended to me, I am able to continue my education without sacrificing the welfare of my loved ones.

For the many times I have doubted my financial capacity to continue, the scholarship has always encouraged me to stay in the College. I thank the UP College of Law administration and its generous supporters for this innovative scholarship program that they have crafted. I have often shared with my friends that I am glad to be under an administration that holistically considers the welfare of the students. This is the first time I have encountered a scholarship program that is primarily needs based, one that looks beyond the academic standing of students. I hope the entire University will be inspired by your generosity and good will. I will be forever thankful for this opportunity.

The UP College of Law Scholarship Fund ("UP Law Scholarship Fund") consists of donations from individual UP Law alumni, alumni batches or groups, and other third parties or entities that are expressly intended and dedicated to support all UP Law scholars.



The UP Law Scholarship Fund accepts any amount of donation.





The donations are consolidated to provide scholars with the following types of support:



Tuition Fee Grant

For the tuition and other fees payable at the time of registration, net of discounts applied for under the Student Learning Assistance System, payable to the University of the Philippines



Book Allowance

For the cost of books and academic materials (Php 10,000.00 a semester), payable direct to the scholar by way of check drawn to the name of the scholar



Monthly Allowance

For the scholar's costs for food, lodging, communication and transportation (Php 10,000.00 a month), payable direct to the scholar by way of check drawn to the name of the scholar




Bar Scholarship

For all official payments for the taking of the bar exams, payable to the Supreme Court or such other manner as may be directed by the Office of the Bar Confidant, in addition to a monthly allowance during the entire period of the bar review and the bar month



As a matter of policy, qualification to the UP Law Scholarship Fund shall be based primarily on economic need, and secondarily, on academic merit.



Applying students may qualify to be part of one of the three tiers introduced by the College according to various financial factors set by the College with the following benefits:

Tier 1 - Full waiver of tuition fee, book allowance, and monthly allowance
Tier 2 - Full waiver of tuition fee and book allowance

Tier 3 - Full waiver of tuition fee
Tier 4 - Book and internet allowance

To apply for the UP College of Law Scholarship Program, students are asked to answer online forms that will be made available to them by the Scholarship Committee within reasonable time from the set deadline. The form shall consist of relevant questions in order to determine the basic and financial information of the applying students and their families.

This shall help the Scholarship Committee determine who are the most economically disadvantaged applicants in order to determine who shall qualify and who shall be placed in each tier.





Tiers are classified primarily based on economic needs, total household income and assets. Secondary considerations include being part of the LGBTQ+ community, Indigenous Peoples, and PWDs. Other considerations shall be given to those who studied in public schools, or those who have provincial permanent address. All factors are supported by evidence.

In the selection of qualified scholars, the Scholarship Committee shall generally observe a points system to avoid recency bias and bias towards those who articulate their concerns better.

The system for points allocation is based on

- The official poverty statistics report by the National Economic and Development Authority (NEDA);
- Gender Equality, Disability, and Social Inclusion (GEDSI) principles;
- · Pre-pandemic student survey; and
- · Consultations with scholars.

The total accumulated points by the applicant determine the tier of their scholarship grant:

Tier 1 - Above 23 points (33 max. points)

Tier 2 - 19 to 23 points

Tier 3 - 14 to 18 points

Tier 4 - Less than 14, but with immediate emergency use
