PHILIPPINE GOVERNMENT'S OBSERVATION ON THE OFFICE OF THE PROSECUTOR'S REQUEST TO RESUME THE INVESTIGATION INTO THE SITUATION IN THE PHILIPPINES, AND THE OFFICE OF THE PROSECUTOR'S RESPONSE TO THE OBSERVATION

On September 8, 2022, the Philippine Government made a submission in response to the Order of the Pre-Trial Chamber I ("the Chamber") of the International Criminal Court ("the Court") inviting the same to provide observations on the Office of the Prosecutor's (OTP) request to resume the investigation into the situation in the Philippines.

Citing Article 53(1) of the Rome Statute, which provides the considerations for the OTP to initiate an investigation, the Philippine Government submitted that the OTP failed to meet the standards therein for the following reasons: "the OTP misinterpreted available information; the situation is inadmissible under Article 17; and the situation is not of sufficient gravity to justify further action by the Court." The Philippine Government also submitted that the Court has no jurisdiction over the situation in the Philippines.

On September 22, 2022, the OTP filed its response to the Philippine Government's Observations. First, it argues that the challenges to jurisdiction and gravity are not properly before the Court, there being no provision in the State to challenge the resumption of an investigation on jurisdictional or gravity grounds at the present stage of proceedings. Second, regarding jurisdiction, it points out that the Philippine Government's contentions on the lack of a widespread or systemic attack on the civilian population and that the crimes were not in furtherance of any state policy relate to the merits of an eventual prosecution and not to the Court's jurisdiction. Third, it contends that the gravity challenge is not supported by facts or the law. Lastly, in relation to Article 18, it argues that the Philippine Government has not demonstrated that it has conducted or is conducting national investigations or prosecutions that sufficiently mirror the investigation authorized by the Chamber I.

REGISTRY REPORT ON ARTICLE 18(2) VICTIM REPRESENTATIONS

In August 27, 2021, the Registry of the International Criminal Court (ICC) submitted 204 victim representations to the Pre-Trial Chamber I. These representations are in connection with the investigation into the Situation in the Philippines for which the Office of the Prosecutor (OTP) had previously requested for judicial authorization to commence. Said investigation is in relation to alleged crimes committed in the context of the Philippine Government's so-called War on Drugs (WoD). The victim representations were submitted pursuant to Article 15(3) of the Rome Statute.

The submission, consisting of representations from approximately 1,530 individual victims and 1,050 families, heavily supported the opening of the investigation while also bringing to light several concerns regarding the effectiveness of the Philippine judicial system and the ability and willingness to investigate the WoD-related crimes.

Report of the United Nations High Commissioner for Human Rights

"The present report examines the implementation of Human Rights Council resolution 45/33 and the progress and results of technical cooperation and capacity-building for the promotion and protection of human rights in the Philippines, including through a United Nations Joint Programme on human rights (UNJP) being implemented with the Government of the Philippines and national partners. The High Commissioner also provides recommendations aiming to promote a transformative approach to human rights-based reforms, strengthen an institutional culture of respect for human rights, ensure justice and redress for victims, and contribute towards the prevention of violations recurring."

UNITED NATIONS GENERAL ASSEMBLY RESOLUTIONS

In 2022, the Philippines, as a member of the United Nations General Assembly, voted in favor of various resolutions tackling different international issues. From over 80 resolutions, only the vote to suspend Russia from the UN Human Rights Council¹ and vote demanding protection and aid for Ukraine² were publicized on the government's official news channels.
