


This book starts with a clear delineation of the concept of torts and quasi-delicts often thought to be the same. It digs deep into each concept as it leads to a discussion of negligence, a concept likewise of great import in this subject. It explores the presumptions of negligence through cases and the different commonly used defenses against the charge of negligence. In the process, it tackles the different categories of causes and the tests used to determine proximate cause. Given a case of negligence, it goes into an examination of the parties liable to go along with a discussion of human relation torts and independent civil actions.

This volume is intended primarily as a teaching tool. When used in tandem with a problem-based method of classroom participation, students should be able to see the practical application of the relevant rules in everyday life. Legal education after all should go beyond mere memorization of rules and recitation of cases and into the analysis and application of rules to actual problems.

This volume focuses on analyzing the law and jurisprudence on Damages. This volume examines the text of Civil Code and traces the development of the doctrines and rules promulgated by the Court. Where necessary, it offers a critique of the rule or its implications or a way to reconcile apparently divergent rulings.

In this volume, U.S. cases are used to help elucidate the principles when the Civil Code provision being discussed was taken from the Uniform Partnership Act of 1914 or the Uniform Limited Partnership Act of 1916. Because these laws have since been amended, the author was careful in including only those cases which were based on these particular versions. As a result, the U.S. cases cited were decided prior to the amendment of the pertinent U.S. law.

Some were for professorial chair lectures while others were written for publication in journals. One was an opinion submitted by Professor Balane to the Supreme Court as amicus curiae in a case involving succession. Others were lectures to judges or lawyers at various forums. Each of the three traditional fields of civil law (according to the Gaian Order as it is called) is represented here.

This book, a guide for the course on credit transactions, tackles the provisions of cited laws based on the subject matter instead of presenting them based on article or section number. It emphasizes certain key concepts by reformatting the language used in the provision cited but without changing the language itself. Excerpts of decisions of the Supreme Court are taken up as well to supplement the discussion and to facilitate the understanding of the subject.

Dr. Owen Lynch demonstrates how colonial policies continue to influence policy making processes even after the adoption of the 1987 Constitution. In particular, he illustrates how the Constitution reaffirms the unjust natural resources allocation concepts used to provide a legal basis for the State's usurpation of rural peoples' customary property rights. State policies (with a few exceptions) remain unchanged because the legal, economic, and bureaucratic elites continue to benefit from the status quo.

The entries in this dictionary are limitedly drawn from multilateral conventions and decisions of international tribunals. The Draft Bangsamoro Basic Law is stirring debate on the extent to which the Constitution can accommodate the aspirations of the Bangsamoro. In the course of the hearings, Congress invited experts on constitutional law to enlighten lawmakers on the legal issues implicated by the draft bill. Among the many resource persons invited by Congress were Dean Merlin Magallona, and Supreme Court Associate Justice Vicente V. Mendoza. Dean Pacifico A. Agabin has also presented his views on this issue in a forum organized by the San Beda Graduate School of Law held in May 2014. The UP Law Center is presenting these perspectives in the hope that it will lead to a constructive debate on the constitutionality of the draft law and clarify legal issues that will ultimately lay the foundations for peace.
